Section 6: Upon completion of his/her term of office, the Vice Chair shall assume 32 the position of Chair. 33 **Section 7:** Upon completion of his/her term of office, the Secretary/Treasurer shall 34 assume the position of Vice Chair. 35 **Section 8:** The Historian shall be appointed by the Chair in consultation with the 36 Executive Committee. 37 **Section 9:** The Executive Committee shall be responsible for ensuring the effective 38 conduct of the section's business, establishing and implementing the 39 operating policies of the section in accordance with these By-Laws and 40 the By-Laws and Policies of the NABT, and representing the section. 41 **ARTICLE V -- DUTIES OF OFFICERS** 12 43 **Section 1:** The chair shall preside at all meetings, appoint and oversee committees 14 and attend NABT board meetings. The Chair will serve as the principal 45 contact between the section and the NABT staff. 46 **Section 2:** The Vice Chair shall recruit membership, establish communications, 47 attend all section and Executive Committee meetings, and stand for the 48 Chair when necessary. 49 **Section 3:** The Secretary/Treasurer shall record and maintain minutes of all 50 meetings, maintain any financial record, and assist the other officers, as 51 required. 52 **Section 4:** The Immediate Past Chair shall advise the other officers, serve as chair 53 of the Awards Committee, and maintain a liaison with the Two-Year 54 College Section of NABT. 55 **Section 5:** The Historian shall record and maintain Section records. Such records 56 shall be filed with the Office of NABT. 57 58

Article VI. Committees

Section 1: The standing committees shall include the following: Conference Planning, Pre-service Teacher Preparation, Faculty Development,

Biology Education Research, Graduate Student, Awards, Publicity, 32 Membership, Nominating, and First-Year Undergraduate Biology. 33 Section 2: Conference Planning: The Conference Planning committee shall 34 coordinate programs and arrange sponsorship and social functions. 35 **Section 3:** Pre-Service Teacher Preparation: The Pre-Service Teacher Preparation 36 committee shall examine and recommend criteria and standards for 37 biology teacher preparation. 38 **Section 4:** Faculty Development: The Faculty Development committee shall 39 examine and establish criteria and standards for college biology faculty 70 and suggest programs and procedures for the development of 71 college/university faculty. 72 **Section 5:** Biology Education Research Committee: The Biology Education 73 Research committee shall promote the scholarship of teaching and 74 learning and its dissemination. 75 Section 6: Graduate Student: The Graduate Student Committee shall coordinate a 76 professional development event for students, encourage participation at 77 the poster session at the national conference, and facilitate networking 78 between graduate students and faculty. 79 Section 7: Awards: The awards committee shall establish criteria for and select the 30 recipients of all Section awards. 31 **Section 8:** Publicity The publicity committee shall coordinate communications 32 between the Section and its membership and other constituencies. A 33 member of this committee will serve as the section webmaster. 34 **Section 9:** Membership: The membership committee shall promote membership 35 and participation in the Section. 36 **Section 10:** Nominating: The nominating committee shall prepare lists of nominees 37 for the various offices, ascertain the willingness of each nominee to 38 serve, if elected, and present the ballot at the annual business meeting. 39 **Section 11:** First-Year Undergraduate Biology: The first-year undergraduate 90 biology committee shall examine the content and skills for introductory 91 biology courses and make recommendations and establish guidelines as 92 appropriate. 93

Section 12: The Chair may appoint <u>ad hoc</u> committees as deemed necessary. The duties of these committees shall be defined at the time of appointment, and such committees shall exist only for the length of time needed to accomplish the task as designated by the Chair (not to exceed one year) or Executive Committee.

- **Section 13:** All committees shall prepare written reports for the annual meeting of the Executive Committee and as requested by the Chair. All reports for the annual meeting must be submitted to the Section Chair.
- **Section 14:** The duties of the standing committees are those stated in Sections 2-11 above and as specified in the Operating Policies; however, committees may be charged with additional responsibility at the Chair's discretion.
- **Section 15:** Standing Committee structure and operating policies shall be set by the Executive Committee and incorporated into the Statement of Operating Policies.

ARTICLE VII -- NOMINATION AND ELECTIONS

- **Section 1:** Nominations for the various elective offices of the section shall be made by the Nominating committee. The Nominating Committee shall nominate at least one officer for each elective position.
- **Section 2:** Elections shall be held during the business meeting at the National Convention. Ties will be resolved by a coin flip.

ARTICLE VIII-- TERMS OF OFFICE

- **Section 1:** All elected officers shall hold office for one year beginning January 1 following election to, or assumption of, office.
- Section 2: Should an officer resign or be unable to complete his/her term of office, the Chair, with the consent of the Executive Committee, shall appoint a member to serve until the next election.
