**I. Call to Order**

Past Chair Dee Millard introduced and thanked Chair-elect Carol Schutte for stepping in and taking over the duties of chair for the Denver convention. Carol was acknowledged for the hard work and efficiency in organizing the TYCC reception, contacting the sponsors and having a speaker. Carol, as acting Chairperson, called the meeting to order at 7:30 am and acknowledged the TYCC Breakfast sponsor – John Wiley and Sons Publishing and their representatives, Lucy Parkinson and Kristy Ruff.

Dennis Gathmann shared that many NABT'ers were asking where the NABT store was. He informed that it was in the basement still boxed up due to cut backs and the austerity program presently in effect. He advised that if anyone wants to see the NABT store back they should let the NABT office and the Board know.

The suggestion was made to have an on-line NABT store.

Carol Schutte shared that the two-year group's membership had in the past been around 13% but that as of October 2009, membership was at 19% of NABT members. Jaclyn Reeves-Pepin, Associate Executive Director of NABT, acknowledge that two-year group as the fastest growing group of NABT.

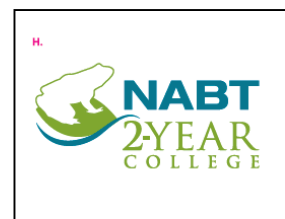
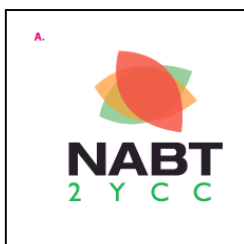
#### V. Old business

A discussion on supplying plaques to past chairs ensued. The question of cost was posed and the suggestion to provide a certificate of appreciation and a donation in the chairs name be made for recognition. Other suggestions:

- Don Emmeluth, as the oldest living chair present, suggested buying the old timers a drink as recognition and appreciation. Betsy Ott suggested it be done at the open bar.
- One larger plaque with the NABT and two-year logos, gavel, etc. with space below for plates with chair names, place and year of service. The plaque could be reside with the current chair and rotate accordingly.

- Jaclyn Reeves-Pepin, Associate Executive Director, was introduced. Jaclyn informed the members that the two-year group was the fastest growing section of NABT and that quite a few new initiatives were in progress. Jaclyn asked the group to stay engaged and announced that she would be in need of volunteers. She commented on the good work done at this convention with kudos to Carol Schutte. This last comment was met with much applause.
- Susan Musante announced a partnership between NABT and AIBS (American Institute of Biological Sciences) that seeks to provide and enrich resources for the two-year biology teacher. They are conducting a survey researching students' perception of biology. The partnership recognizes the importance of the two-year college in teaching introductory biology and would like to continue the conversation with the two-year group with an invitation to participate. The goal of the group is to engage students in the process of science and incorporate Evolution as an important concept in introductory biology. Susan welcomed our future involvement and offered to send information via the list-serve generated at the meeting and/or through contact with Jaclyn Reeves-Pepin, Associate Executive Director-NABT.
